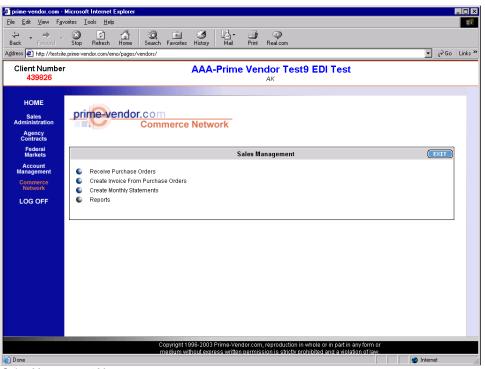
## Using the Commerce Network

## Sales Management

Sales Management is where a supplying vendor will receive and process purchase orders. The Sales Management function can also create and send invoices to customers and it can compile monthly statements of items bought and sold.
